Haverhill (Essex)

Haverhill is a city in Essex County with 9,932 residents aged 65 and older. Compared to state average rates, older residents in Haverhill report lower rates of breast cancer, cataract, glaucoma, and ischemic heart disease. However, they have higher rates of tooth loss, anemia, asthma, chronic kidney disease, chronic obstructive pulmonary disease (COPD), congestive heart failure (CHF), diabetes, hypertension, pressure ulcer, substance and tobacco use disorders, depression, anxiety disorder, schizophrenia, and high cholesterol. Older Haverhill residents are less likely to take the health promotion steps of meeting CDC guidelines for aerobic activity and receiving flu and shingles vaccines. Community resources to support healthy aging include two adult day health centers, three community health centers, a COA, a home health agency, three assisted living facilities, two hospice agencies, a hospital, a public library, 51 primary care providers, seven skilled nursing facilities, and three public universities or community colleges.

TECHNICAL NOTES

*For more information on data sources, measures, and methodology used in the 2025 Massachusetts Healthy Aging Data Report see our technical documentation at (<u>healthyagingdatareports.org</u>). For most indicators, the community and state values are estimates derived from sample data. Thus, it is possible that some of the differences between state and community estimates may be due to chance associated with population sampling. We use the terms "Better" and "Worse" to highlight differences between community and state estimates that we are confident are <u>not</u> due to chance. We balance two goals. First, we aim to report data at very local levels because we believe change is often locally driven. Second, we vowed to protect the privacy of the people providing the information reported. Thus, given the constraints of the data analyzed, we used a hierarchical approach to reporting.
