Methuen (Essex)

Methuen is a city in Essex County with 9,085 residents aged 65 and older. Compared to state average rates, older residents in Methuen report lower rates of Alzheimer's disease or related dementias, fibromyalgia/chronic pain/fatigue, peripheral vascular disease, substance use disorder, depression, and PTSD. However, they have higher rates of tooth loss, anemia, chronic kidney disease, chronic obstructive pulmonary disease (COPD), congestive heart failure (CHF), diabetes, glaucoma, hypertension, ischemic heart disease, lung cancer, osteoarthritis/rheumatoid arthritis, and high cholesterol. Older Methuen residents are less likely to take the health promotion steps of meeting the CDC guidelines for aerobic activity and getting vaccinated for shingles and the flu. Community resources to support healthy aging include three community health centers, a COA, two assisted living facilities, three home health agencies, a hospital, a public library, 26 primary care providers, and two skilled nursing facilities.
