## **Newburyport (Essex)**

Newburyport is a city in Essex County with 3,977 residents aged 65 and older. Older residents in Newburyport show better health outcomes compared to state average rates, with lower rates of tooth loss, Alzheimer's disease or related dementias, anemia, asthma, chronic kidney disease, chronic obstructive pulmonary disease (COPD), congestive heart failure (CHF), diabetes, fibromyalgia/chronic pain/fatigue, glaucoma, heart attack, hypertension, peripheral vascular disease, tobacco use disorder, and schizophrenia. However, they have higher rates of anxiety disorder and high cholesterol. They are more likely to engage in the health promotion activity of having regular dental exams. Community resources supporting healthy aging include a COA, one hospice agency, two assisted living facilities, one hospital, one public library, 69 primary care providers, three skilled nursing facilities, and one public university or community college.

### **TECHNICAL NOTES**

\*For more information on data sources, measures, and methodology used in the 2025 Massachusetts Healthy Aging Data Report see our technical documentation at (<u>healthyagingdatareports.org</u>). For most indicators, the community and state values are estimates derived from sample data. Thus, it is possible that some of the differences between state and community estimates may be due to chance associated with population sampling. We use the terms "Better" and "Worse" to highlight differences between community and state estimates that we are confident are <u>not</u> due to chance. We balance two goals. First, we aim to report data at very local levels because we believe change is often locally driven. Second, we vowed to protect the privacy of the people providing the information reported. Thus, given the constraints of the data analyzed, we used a hierarchical approach to reporting.
