## **West Newbury (Essex)**

West Newbury is a town in Essex County with 1,052 residents aged 65 and older. Compared to state average rates, older residents fare better on some healthy aging indicators with lower rates of tooth loss, Alzheimer's disease or related dementias, anemia, asthma, benign prostatic hyperplasia, chronic kidney disease, chronic obstructive pulmonary disease (COPD), congestive heart failure (CHF), diabetes, fibromyalgia/chronic pain/fatigue, glaucoma, heart attack, hypertension, ischemic heart disease, osteoarthritis/rheumatoid arthritis, osteoporosis, peripheral vascular disease, pressure ulcer, substance and tobacco use disorders, depression, anxiety disorder, and schizophrenia. They are more likely to take the health promotion step of having an annual dental exam. Community resources to support healthy aging include a COA and a public library.
