Dracut (Middlesex)

Dracut is a town in Middlesex County with 5,336 residents aged 65 and older. Dracut's older residents fare better on many healthy aging indicators compared to state average rates, with lower rates of hip fracture, Alzheimer's disease or related dementias, cataract, fibromyalgia/chronic pain/fatigue, osteoporosis, prostate cancer, substance use disorder, depression, PTSD, and schizophrenia. However, they experience higher rates of tooth loss, chronic kidney disease, chronic obstructive pulmonary disease (COPD), congestive heart failure (CHF), diabetes, hypertension, ischemic heart disease, and high cholesterol. Dracut's older residents are less likely to meet CDC guidelines for aerobic activity or receive flu and shingles vaccines. Community resources to support healthy aging include a COA, two assisted living facilities, one adult day health center, three home health agencies, one public library, and three primary care providers.
